#### **BUDGET WORKSHOP**

Our focus for 2023 will be to continue with road rehabilitation, drainage study, and maintenance projects at the pool and park. Our highest priority is rehabilitating the volleyball court at the city park and concreting the picnic area at those facilities. We also need to rehabilitate the city pool that is now pulling away from the concrete around. We are focusing on projects that show progress to the community. We also have the American Rescue Plan Act project that will begin in the new fiscal year.

# DISCUSS AND TAK ALL APPROPRIATE ACTION ON THE PROPOSED TAX RATE FOR FY 2021-22.

Secretary Scearce presented the worksheets provided by the Wharton County Tax Assessor. Our current tax rate is .17000/\$100. Our no new revenue tax rate is figured to be .15819/\$100. Our voter approval tax rate is .17001/\$100. Alderman Tomchesson made a motion to propose the 2022-23 tax rate as .17000/\$100, seconded by Alderman Webster. The motion carried by unanimous vote.

# DISCUSS AND TAKE ALL APPROPRIATE ACTION ON ABANDONING FRANK STREET AND JONES STREET IN THE CITY OF EAST BERNARD.

Alderman Szymanski began discussions with his concerns over this agenda item. 1) sets a bad precedent for the City of East Bernard. 2) The current state of the auto industry is vulnerable, and we have no way of knowing the success rate of the dealership here in East Bernard. 3) Optics-how would this look to the residents behind that street and with the knowledge of the mayor working for Destination Ford. He is not opposed to Ford or Destination Ford but is opposed to the abandoning streets. Alderman Viktorin also expressed his concerns over this agenda item. The other residents in the area need access to this street and do in fact use the street. He is opposed to the abandonment but thanked Destination Ford for all their community involvement. Alderman Viktorin made a motion to deny abandoning Frank Street and Jones Street, seconded by Alderman Webster. The motion carried by unanimous vote.
