## **ORDINANCE NO. 2020-006**

**SECTION 1.** That the appropriations for the twelve (12) month fiscal period beginning October 1, 2020 and ending September 30, 2021, for the support of the general government of the City of East Bernard, Texas be fixed and determined for said terms in accordance with the expenditures shown in the City's 2020 Budget, a copy of which is appended hereto as Exhibit A;

**SECTION 2**. That the Budget, as shown in words and figures in Exhibit A, is hereby approved in all respects and adopted as the City's 2020 Budget for the twelve (12) month fiscal period beginning October 1, 2020 and ending September 30, 2021.
