Do I qualify for Driver's Safety Course?

- 1. Is your ticket a moving violation (were you speeding or did you run a stop sign?)
 - 2. Were you going LESS than 25 miles over the speed limit?
 - 3. Has it been 12 months or longer since you took a Driver's Safety Course?

If you answered YES to all 3 questions, you qualify!

CDL DRIVERS DO NOT QUALIFY TO TAKE A DRIVER'S SAFETY COURSE.

TO REQUEST A DRIVING SAFETY COURSE, PLEASE FOLLOW DIRECTIONS BELOW.

You must enter a plea of NOLO CONTENDERE or GUILTY and send the above requirements to the court along with this signed and notarized form.

- 1. COPY OF VALID DRIVER'S LICENSE
- 2. COPY OF VALID INSURANCE (YOU MUST HAVE INSURANCE TO REQUEST DSC)
- 3. COPY OF CITATION
- 4. CASHIER'S CHECK OR MONEY ORDER FOR \$144.00: MADE PAYABLE TO *EAST BERNARD MUNICIPAL COURT*
- 5. SELF-ADDRESSED STAMPED ENVELOPE

INSTRUCTIONS FOR ENTERING PLEA (NO DSC OR DEFERRED REQUEST)
